Effective with the 2011 Dues & Workday Assessment, which will be mailed out with the December 2011 newsletter, each member is required to provide three items back to the Club with that payment.

1. Check for the correct amount of annual dues and any workday assessment stated on the invoice.
2. Proof of current NRA membership; either a photocopy of your membership card or a mailing label from your NRA magazine showing both your NRA ID number and a non-expired expiration date.
3. A signed Range Safety Certification form.

Failure to include any of these items will result in your payment being mailed back to you for inclusion of the correct info. In the event you are unable to get the correct payment/info in the hands of the Club by January 31, your name will be dropped from Club rolls, and your membership terminated.

## **DUES, WORKDAY ASSESSMENTS AND NRA MEMBERSHIP REQUIREMENT COMING UP**

It's that time of year again – the Clubs annual dues and workday assessment notices are going out with the December newsletter. They are due December 31 and must be in the Club mailbox by January 31 or your membership will not be renewed. There are no exceptions to this rule. **In order to send the dues notices, everyone will receive the December newsletter via the US Postal Service Please make sure the Club has your correct mailing address.**
